## STATEMENT OF CLAIM

- 1. The Plaintiffs are eight of the nine Chiefs of the Mi'gmaq First Nations located in the portion of Mi'gma'gi (the territory of the Mi'gmaq) that is currently known as New Brunswick. The Plaintiffs, on their own behalf, on behalf of the members of their respective First Nations, and on behalf of their respective Districts of Gespe'gewa'gi and Signigtewa'gi of the Mi'gmag Nation, and on behalf of all members of the Mi'gmaq Nation claim:
  - a. a declaration that the Mi'gmaq Nation holds Mi'gmaq Title to the lands, including the land, airspace, land covered by water, offshore and inshore water bodies, foreshore, rivers, lakes and streams, described in Schedule "A", or to such portions thereof for which this Court may find the evidence sufficient (the "Title Area");
  - b. a declaration that the Defendants, or each of them, unjustifiably infringed Mi'gmaq Title in respect of the Title Area;
  - c. a declaration that the Defendants, or each of them, breached their fiduciary duties towards the Mi'gmaq Nation and have failed to act in accordance with the Honour of the Crown (the "Constitutional Duties");
  - d. a declaration that the Defendants account for any benefit they have received flowing from or as a result of Mi'gmaq Title in the Title Area;
  - e. an order that the Defendants disgorge any such benefit received;
  - f. damages, including equitable damages, arising from the unjustifiable infringement of Mi'gmaq Title;
  - g. damages and compensation from the Defendants, jointly and severally, for the Defendants' breaches of the Crown's Constitutional Duties, and for the unlawful occupation, appropriation, removal of resources from, and infringement of, Mi'gmaq Title over the Title Area, including infringements arising from the Defendants and others being in occupation of the Title Area without permission from the Mi'gmaq Nation;
  - h. a declaration that, in respect of fee simple lands and industrial freehold lands in the Title Area, that Mi'gmaq Title burdens the Crown's allodial title;
  - i. in respect of lands purported to be Crown lands that are subject to a leasehold interests, a declaration that such leases are subject to Mi'gmaq Title and the vesting of the reversion and any remainder to the Plaintiffs, on behalf of the Mi'gmaq Nation;
  - j. vesting in possession/interest in favour of the Plaintiffs, on behalf of the Mi'gmaq Nation, of the lands purported to be Crown lands bearing the property identification numbers set out in Schedule "B";

- k. a determination, with respect to the lands purported to be Crown lands other than those bearing the property identification numbers set out in Schedule "B", of whether those lands should vest in possession in favour of the Plaintiff, on behalf of the Mi'gmaq Nation;
- 1. an order that the Defendants consult with the Plaintiffs, on behalf of the Mi'gmaq Nation, with respect to the creation of an effective means to:
  - i. allow a First Nation to register lands held pursuant to Aboriginal Title;
  - ii. allow a First Nation to record and register interests in lands granted by or created by the First Nation in lands held pursuant to Aboriginal Title;
  - iii. allow that First Nation a means of enjoying the economic benefits conferred by Aboriginal Title.
- m. an order that if, after one year, the Plaintiffs and the Defendants are unable to agree upon an effective means to provide for the matters set out in the previous paragraph, either party will be at liberty to apply to the court in these proceedings for a further order addressing this matter;
- n. a declaration that the Defendants have breached the rights of the members of the Mi'gmaq Nation pursuant to Section 15 of the *Canadian Charter of Rights and Freedoms*, Part 1 of the *Constitution Act*, 1982, being Schedule B to the *Canada Act* 1982 (UK), 1982, c 11 a (the "Charter") by:
  - i. failing to establish effective administrative means to recognize, protect and if necessary adjudicate the existence, scope and extent of Mi'gmaq Title;
  - ii. failing to establish effective administrative means to provide compensation for government decisions that injuriously affect or appropriate Mi'gmaq Title.
- o. a declaration that the Defendants have breached the Honour of the Crown by:
  - i. failing to establish effective administrative means to recognize, protect and if necessary adjudicate the existence, scope and extent of Mi'gmaq Title of the Plaintiffs prior to making decisions that could have a significant adverse effect on or unjustifiably infringe the Mi'gmaq Title of the Mi'gmaq Nation;
  - ii. failing to establish effective administrative means to provide compensation for government decisions that injuriously affect or appropriate Mi'gmaq Title prior to making decisions that could have a significant adverse effect on or unjustifiably infringe Mi'gmaq Title.
- p. interlocutory and permanent injunctive relief, including but not limited to:

- i. an interlocutory and permanent injunction prohibiting the appropriation by the Defendants of any part of the Title Area without the consent of the Plaintiffs, on behalf of the Mi'gmaq Nation; and
- ii. an interlocutory and permanent injunction prohibiting the issuance, renewal, or granting of tenures to third parties in any manner which may infringe on Mi'gmaq Title without the consent of the Plaintiffs, on behalf of the Mi'gmaq Nation;
- q. a declaration that any statutes enacted by the Defendants that meaningfully diminish the right of the Mi'gmaq Nation to exclusively occupy the Title Area are constitutionally invalid, or constitutionally inapplicable to the Title Area.
- r. pre- and post-judgment interest;
- s. costs on a substantial indemnity basis; and
- t. such further and other relief as this Honourable Court may deem just.
- 2. The Plaintiffs seek relief only as against lands held by the Crown and Crown Corporations, however so held.
- 3. In respect of fee simple lands that are not held by the Crown, the Plaintiffs seek no relief against fee simple holders who hold fee simple title in the Title area ("Fee Simple Holders"). The incidents of fee simple title enjoyed by Fee Simple Holders, including the incident of peaceful possession, are not placed in issue by the Plaintiffs. As outlined in paragraph 1(h), however, the Plaintiffs seek damages and compensation on behalf of the Mi'gmaq Nation from the Defendants, jointly and severally, for the infringement of Mi'gmaq Title in the granting of fees simple in the Title Area to Fee Simple Holders.
- 4. In respect of industrial freehold lands that are not held by the Crown, the Plaintiffs similarly seek no relief against the holders of industrial freehold lands in the Title Area ("Industrial Freehold Landowners"). The incidents of industrial freehold land ownership are not placed in issue by the Plaintiffs, as outlined in paragraph 1(h), however, the Plaintiffs seek damages and compensation on behalf of the Mi'gmaq Nation from the Defendants, jointly and severally, for the breach of Mi'gmaq Title in the granting of industrial freehold land ownership in the Title Area to Industrial Freehold Landowners.
- 5. The Plaintiffs do not seek a declaration of Mi'gmaq Title in paragraph 1(a) that binds Fee Simple Holders and Industrial Freehold Landowners with respect to such Fee Simple Holders and Industrial Freehold Landowners' property rights. However, the Plaintiffs do seek a declaration on behalf of the Mi'gmaq Nation in respect of fee simple and industrial freehold lands that Mi'gmaq Title burdens the Crown's allodial title.

6. In respect of fee simple and industrial freehold lands in the Title Area that are not held by the Defendants, exclusive use and possession of these lands is not sought by the Plaintiffs in this litigation. For greater certainty, the Plaintiffs, on behalf of the Mi'gmaq Nation, seek exclusive use and possession of Crown lands only. With respect to fee simple and industrial freehold lands that are not held by the Defendants, the Plaintiffs seek a declaration of Mi'gmaq Title that burdens the Crown's allodial title only.

## The Parties

- 7. The Plaintiffs are the duly elected Chiefs representing eight of the nine Mi'gmaq First Nation communities located within the portion of Mi'gma'gi (the territory of the Mi'gmaq) that is currently known as New Brunswick.
- 8. Amlamgog (Fort Folly) First Nation, Natoaganeg (Eel Ground) First Nation, Oinpegitjoig (Pabineau) First Nation, Esgenoôpetitj (Burnt Church) First Nation, Tjipõgtõtjg (Buctouche) First Nation, L'nui Menikuk (Indian Island) First Nation, Ugpi'ganjig (Eel River Bar) First Nation and Metepenagiag Mi'kmaq Nation (collectively, the "Mi'gmaq Communities") are each a body of "Indians" for whose use and benefit in common purported Crown lands have been set apart and each constitute a "band" recognized pursuant to the *Indian Act*, R.S.C. 1985,c. I-5 (the "*Indian Act*").
- 9. Mi'gma'gi is a geographic territory composed of seven districts, which include what is today known as Nova Scotia, Prince Edward Island, New Brunswick, the Gaspé Peninsula and parts of Québec, parts of Newfoundland and Labrador, part of Maine and the Islands in the Baie des Chaleurs, as well as their surrounding coastal and marine areas. Mi'gma'gi includes not only these land areas, but also the waters, islands, air and resources of and around them.
- 10. The Mi'gmaq Communities are located within the Districts of Gespe'gewa'gi and Signigtewa'gi, which are indicated in the District Map attached hereto as Schedule "C".
- 11. The Plaintiffs bring this action on their own behalf, on behalf of the members of their respective First Nations, and on behalf of their respective Districts of the Mi'gmag Nation, and on behalf of all members of the Mi'gmaq Nation, all of whom are Indians within the meaning of section 91(24) of the *Constitution Act*, 1867, 30 & 31 Vict.,
  c. 8 (the "Constitution Act, 1867") and Aboriginal Peoples within the meaning of section 35 of the *Constitution Act*, 1982, being Schedule B to the *Canada Act 1982 (UK)*, 1982, c 11 (the "Constitution Act, 1982").
- 12. The Mi'gmaq Nation is an Indigenous people, and a distinctive Aboriginal group, with common territory, language, culture, values, customs, practices, traditions, beliefs, kinship ties, and legal and political systems with respect to the lands and waters within Mi'gma'gi.
- 13. The Plaintiffs have commenced this action with respect to the portion of Mi'gma'gi currently known as New Brunswick. This is inclusive of territory claimed by the Wolastoqey and Peskotomuhkati, or shared by the Wolastoqey, Peskotomuhkati, and Mi'gmaq, as members of

the Wabanaki Confederacy and pursuant to protocols and understandings between these Nations.

- 14. The Mi'gmaq Nation as it exists today is the continuation and successor to the Mi'gmaq Nation as it existed prior to and at contact with Europeans and the assertion of sovereignty by the British Crown.
- 15. The Defendant, the Attorney General of Canada ("Canada"), is the representative of His Majesty the King in Right of Canada and is named in these proceedings pursuant to section 23(1) of the *Crown Liability and Proceedings Act*, R.S.C. 1985, c. C-50, as amended.
- 16. Canada has legislative jurisdiction in relation to "Indians and lands reserved for the Indians" pursuant to subsection 91(24) of the *Constitution Act*, 1867, subject to the rights and interests of the Plaintiffs.
- 17. The Defendant, the Province of New Brunswick ("New Brunswick"), is the representative of His Majesty the King in Right of the Province of New Brunswick and is named in these proceedings pursuant to sections 3, 11, and 12 of the *Proceedings Against the Crown Act*, R.S.N.B. 1973, c, P-18, as amended.
- 18. New Brunswick is vested with the administration, control and beneficial interest in purported provincial Crown lands pursuant to section 109 of the *Constitution Act*, 1867, subject to the rights and interests of the Mi'gmaq Nation.
- 19. New Brunswick has legislative jurisdiction over lands in New Brunswick pursuant to subsections 92(5) and 92(13) of the *Constitution Act, 1867*, subject to the rights and interests of the Plaintiffs.
- 20. The Defendant, the New Brunswick Power Corporation ("NB Power"), is a Crown corporation of the Province of New Brunswick and is named in these proceedings pursuant to sections 3, 11, and 12 of the *Proceedings Against the Crown Act*, R.S.N.B. 1973, c, P-18, as amended.
- 21. The Defendant, the New Brunswick Regional Development Corporation ("Regional Development Corporation"), is a Crown corporation of the Province of New Brunswick and is named in these proceedings pursuant to sections 3, 11, and 12 of the *Proceedings Against the Crown Act*, R.S.N.B. 1973, c, P-18, as amended.
- 22. Together, Canada, New Brunswick, NB Power and Regional Development Corporation are referred to in these proceedings as the Defendants.
- 23. The Defendants are the successors to the British Crown, and therefore have a constitutional relationship with the Plaintiffs.

## **Material Facts**

- i) The Title Area
- 24. The Mi'kmaq Nation, has occupied and cared for the lands and waters of Mi'gma'gi since time immemorial.
- 25. Prior to, and at the time of European contact and the assertion of British sovereignty, Mi'gma'gi was, and continues to be, occupied and possessed communally by the Mi'gmaq Nation. Mi'gma'gi is the homeland of the Mi'gmaq, and at all material times the connection of the Mi'gmaq to Mi'gma'gi has been of central significance to and the source of the distinctive culture of the Mi'gmaq.
- 26. The Plaintiffs only seek remedies in this litigation with respect to the portion of Mi'gma'gi currently referred to as New Brunswick, including the land, subsurface land and minerals, airspace, land covered by water, offshore and inshore water bodies, foreshore, rivers, lakes and streams situation within this area. A map of the Title Area within New Brunswick is included in Schedule "A". The Plaintiffs reserve the right to claim Mi'gmaq Title in respect of the whole or any portions of Mi'gma'gi in the future.
- 27. Prior to and at the assertion of British sovereignty, the Mi'gmaq had a sophisticated system of governance which provided for decision-making at the Nation, District, and local or watershed level. Under this system of governance, Mi'gmaq people in each District and local area had use of that District, including all of its lands, waters, and resources. However, the Mi'gmaq as a whole had occupation of all of Mi'gma'gi (including the entire Title Area), and members were able to travel and harvest throughout Mi'gma'gi (including the Title Area), subject only to such restrictions as were imposed by local or district Chiefs and heads of families.
- 28. Prior to and at the assertion of British Sovereignty, the Mi'gmaq were a part of a larger Confederacy of Nations, known as the Wabanaki Confederacy, which included the Wolastoqey and Peskotomuhkati Nations. From time to time, the members of the Wabanaki Confederacy used each other's territory, pursuant to Wampum agreements, protocols and understandings between these Nations.
  - ii) Mi'gmaq Title
- 29. Prior to and at the assertion of British sovereignty, the Mi'gmaq exclusively used, occupied, and exercised effective control over the lands and waters of the Title Area. This is inclusive of territory where there was shared exclusivity between the Wolastoqey and Mi'gmaq, as members of the Wabanaki Confederacy and pursuant to protocols and understandings between these Nations.
- 30. Prior to and at the assertion of British sovereignty, the Mi'gmaq continuously had and exercised practices, customs, traditions and activities throughout all of the lands and waters of the Title Area, including hunting, fishing, gathering and other resource-harvesting activities, trade, and cultural and spiritual practices.

- 31. Prior to and at the assertion of British sovereignty, the Mi'gmaq continuously hunted, fished, and harvested in their territory and have used, cared for, and occupied the natural resources and all components on the natural resources therein. They have obtained their livelihood and subsistence from their territory and the natural resources thereof, and have continuously possessed, controlled and managed, and to the extent possible still possess, control and manage, the natural resources of their territory within the Title Area.
- 32. Prior to and at the assertion of British sovereignty, the Mi'gmaq enjoyed a special relationship with the land, waters and resources of what is now known as the Province of New Brunswick. The relationship of the Mi'gmaq with the land, water and all natural resources within the Title Area is the foundation upon which the Plaintiffs, and their ancestors, interact and govern their communities, and is an expression of Mi'gmaq law.
- 33. Prior to and at the assertion of British sovereignty, the Mi'gmaq exercised jurisdiction over the Title Area pursuant to Mi'gmaq legal and political regimes governing the use and occupation of land, and continues to do so today.
- 34. At all relevant times, from the assertion of British sovereignty to the Peace and Friendship Treaties between the British and the Mi'gmaq from 1725 to 1779 the British Crown recognized Mi'gmaq ownership and jurisdiction over the lands and waters of Mi'gma'gi, including the Title Area.
  - iii) The Peace and Friendship Treaties
- 35. The Mi'gmaq have never ceded their sovereignty and title over Mi'gma'gi.
- 36. Beginning in 1726, the Mi'gmaq entered into sacred, constitutionally protected Treaties of Peace and Friendship with the British Crown, which recognized Mi'gmaq Nationhood, title and rights.
- 37. In entering into these Treaties, the Mi'gmaq did not cede or surrender their Mi'gmaq Title of ownership and stewardship over the lands and waters of Mi'gma'gi, including the Title Area to the Crown.
- 38. Mi'gmaq Title has never been extinguished through surrender or legislation, and survives today.
- 39. The Plaintiffs reserve the right to claim Mi'gmaq Title and rights in respect of the whole or any portions of Mi'gma'gi outside the Title Area depicted in Schedule "A" in the future.

## Infringement of the Plaintiffs' Mi'gmaq Title by the Crown

- 40. Canada and New Brunswick and their predecessors had and have a duty to respect and protect Mi'gmaq Title.
- 41. The Defendants have infringed upon or otherwise breached their Constitutional Duties in respect of Mi'gmaq Title in the Title Area by alienating lands and undertaking, authorizing

and/or permitting resource extraction and land use activities throughout the Title Area without the consent of the Mi'gmaq Nation.

- 42. Such uses and alienations of land were in breach of the Defendants' duties to respect and protect Mi'gmaq Title and have unjustifiably infringed Mi'gmaq Title.
- 43. In particular, the Defendants breached their duties to respect and protect Mi'gmaq Title by actions including, but not limited to:
  - a. issuing, replacing, and renewing licenses, leases, permits, authorizations, grants and other tenures (collectively, the "Tenures") to third parties or otherwise occupying, managing, and allocating land and resources in a manner which interferes with Mi'gmaq Title;
  - b. conveying land to themselves and to third parties without regard to Mi'gmaq Title;
  - c. passing laws which purport to enable or authorize the Defendants to alienate lands and resources to third parties or to use those resources for their own use or benefit;
  - d. purporting to exercise management, ownership and control over lands and resources without regard to Mi'gmaq Title;
  - e. committing or authorizing nuisances, trespass or other interferences which restrict or interfere with Mi'gmaq Title;
  - f. deriving royalties and other benefits from the lands and resources and denying the Mi'gmaq Nation the right to receive benefits therefrom;
  - g. failing to protect and sustainably manage the lands and resources;
  - h. failing to adequately consult and/or accommodate the Mi'gmaq Nation or otherwise discharge the Crown's fiduciary duties or the Honour of the Crown in respect of the above-named activities (the "Constitutional Duties"); and
  - i. such other infringements as counsel may advise.
- 44. Such infringements were not justified. These infringements were not made after the discharge of the Defendants' procedural duty to consult and accommodate; the Defendants' actions were not backed by a compelling and substantial objective; and the governmental actions were not consistent with the Constitutional Duties of the Defendants.
- 45. The Defendants owe the Mi'gmaq Nation compensation for infringements on their Mi'gmaq Title by parties other than the Defendants, for the loss of use of their lands within the Title Area, and for breach of fiduciary duties and the Honour of the Crown.
- 46. In respect of the lands in the Title Area that are not held by the Defendants, the return of these

lands is not sought by the Plaintiffs in this litigation, in spite of the unjustified infringements on them that have been authorized by the Defendants. The compensation that the Defendants owe the Mi'gmaq Nation in respect of these lands must concomitantly increase to account for the permanence of the Mi'gmaq Nation's' loss of use of these lands.

- 47. Furthermore, the Defendants themselves purport to have ownership of some of the Mi'gmaq Nation's' lands within the Title Area. Upon a declaration of Mi'gmaq Title:
  - a. all such lands immediately vest in interest to the Plaintiffs, on behalf of the Mi'gmaq Nation;
  - b. the Plaintiffs, on behalf of the Mi'gmaq Nation, are entitled to vesting in possession of all purported Crown lands within the parts of Schedule "A" which are declared to be Mi'gmaq Title lands;
  - c. with respect to purported Crown lands subject to a leasehold interest, a declaration that such leases are subject to Mi'gmaq Title and the vesting of the reversion and any remainder in the Plaintiffs, on behalf of the Mi'gmaq Nation;
  - d. compensation for past and ongoing infringement of Mi'gmaq Title is due from each respective Defendant, to be reduced where appropriate to account for lands that are returned in possession of the Plaintiffs, on behalf of the Mi'gmaq Nation;
  - e. compensation for future infringement of Mi'gmaq Title is due from each respective Defendant with respect to Mi'gmaq Title lands which are not vested in interest and/or possession to the Plaintiffs, on behalf of the Mi'gmaq Nation.
- 48. In addition, to the extent that resources, such as minerals and timber, have been removed from the Title Area by the Defendants or by persons not involved in this litigation, where such removal was done with the permission of the Defendants, the Defendants owe the Mi'gmaq Nation compensation for the value of these resources.
- 49. In addition, to the extent that lands and resources within and on the Title Area have been lost or damaged by the Defendants or by persons not involved in this litigation, where such loss or damage was done with the permission of the Defendants, the Defendants owe the Mi'gmaq Nation compensation for the value of these resources and for the damage to the lands.
- 50. The amount of compensation that the Defendants owe the Mi'gmaq Nation will be further particularized by the evidence to be adduced at trial.
- 51. In addition, an interim and permanent injunction is warranted to prevent further or new interference with the Mi'gmaq Title throughout the Title Area.
- 52. Moreover, any statutes enacted by the Defendants that meaningfully diminish the right of the Mi'gmaq Nation to exclusively occupy the Title Area is constitutionally invalid, or constitutionally inapplicable to the Claim.

- 53. The Plaintiffs plead and rely upon:
  - a. Section 91(24) of the Constitution Act, 1867, 30 & 31 Vict., c. 8;
  - b. Sections 25, 35, and 52 of the *Constitution Act*, 1982, being Schedule B to the *Canada Act 1982 (UK)*, 1982, c 11;
  - c. Canadian Charter of Rights and Freedoms, Part 1 of the Constitution Act, 1982, being Schedule B to the Canada Act 1982 (UK), 1982, c 11 a.;
  - d. The United Nations Declaration on the Rights of Indigenous Peoples;
  - e. United Nations Declaration on the Rights of Indigenous Peoples Act, SC 2021, c 14.
